

YouTube Blocks My 'Dream of Goose' Video

Today is Sunday, February the 28th and last night, about 8:20, I received a very ominous email from YouTube: ***'due to a copyright claim your YouTube video has been blocked. This means that your video can no longer be played on YouTube and you may have lost access to some features of YouTube. The video title 'End of the Antichrist in Psy's Dream of Goose'.***

When I posted this video almost three years ago, they complained almost immediately at that time and they blocked it because I included some of the copyrighted music. Well, I redid the video, I reposted it without any of the music. Now they are coming after me again and trying to block it because of some video content. This is entirely bogus.

And they continue: ***'The copyrighted song, 'Psy, Dream of Goose' performance at 2013 Soul Concert happening claimed by YG Entertainment.'*** Well, I looked them up on Wikipedia. They are a huge billion dollar corporation in South Korea. My video on 'Psy's Dream of Goose' has been getting about one view per day, actually a little less. Last year in all of 2015 it got 289 views. Are they trying to tell me that my little video which gets less than one view a day is some kind of a threat to that gigantic corporation? Something sounds very fishy.

They continue: ***'Why this can happen. Your video might contain copyrighted content. Copyright owners can choose to block YouTube videos that contain their content.'*** Well, no they can't because I have a right under the Fair Use clause of US copyright laws to criticize or comment on any work that's on YouTube or anywhere. Not only videos; but if it's printed material, I can use excerpts and talk about it. I have that legal right. Well, I have filed a complaint with YouTube, I have responded to YG Entertainment. As of this morning, they have reinstated the video, at least while my appeal is in progress. I certainly hope they listen to my appeal and refuse YG's request. They have no legal right to block that video of mine.

Personally, I think they are upset with the recent video I did on 'Daddy' because that video hits home. I show where that video is telling us that the Antichrist's body comes from Satan. And on that point I would like to mention, I got a very interesting letter, I believe it was yesterday, and this subscriber wrote to me and she said the reason Psy plays all

three people in that video- the father, the grandfather and the young boy- is because the Antichrist is a clone and that is what they are telling us. And in fact, if you remember, at the beginning of that video, 'Daddy', no mother is shown even though supposedly she is in childbirth and that is what the message of that video is. I don't know why they want to hide it.

In any a case, I think that is what they are really objecting to and they're taking it out on this other video. And this other video does show a very interesting scene at the very end where Psy, playing the Antichrist, is cast into Hell and if I remember I will try to put a link to that video below. And by the way, YouTube says that if my appeal is not granted, if they overturn my appeal, they have a right to delete my entire channel so if some day you see that my videos have all been deleted, let me assure you now I did not do that. Every video I have ever posted is still available on YouTube. I would never take down my channel. If you see it taken down, that is what has happened and that's why I am making this video to alert you to that possibility.
